General Terms and Conditions

General Terms and Conditions “Protection against Loss”

Contracting parties: The contracting parties are BonusCard.ch Ltd (hereinafter referred to as the “Issuer”) and the “Cardholder”.

Protection against loss and against card misuse: All main and additional cards (hereinafter referred to as “Cards”) are protected which are settled via a card account (hereinafter referred to as “Account”) for which a valid protection against loss exists. The protection against loss covers without restriction and without deductible, all direct damage caused by the misuse of a protected Card by third parties on the Account. The loss protection covers the costs for replacement cards and replacement PIN codes. The protection against loss only covers losses if the General Terms and Conditions of the Issuer for the Card in question have been fully complied with by the Cardholder.

Costs for protection against loss:

CHF 18 per year

Duration: The loss protection begins with the debit date of the fee on the Account and is valid for one year. It is tacitly renewed for a further year, unless it is cancelled in good time. The fee is debited in advance to the Account. The termination can be done by either party at any time in writing and without giving reasons. The benefits expire 30 days after written termination – in the event of closure of the Account, they expire immediately.

Further provisions: The Issuer reserves the change of these General Terms and Conditions at any time. Amendments are notified in writing or in any other reasonable form and are deemed to be approved unless the protection against loss is not terminated before the changes take effect. The Issuer may terminate this contract with rights and obligations and any of its rights and/or obligations under this contract to third parties in Switzerland and abroad at any time. The Cardholder agrees to such a transfer with discharging effect for the Issuer.

This contract is subject to Swiss substantive law. The place of jurisdiction, and in the case of place of performance and debt collection if the Cardholder is domiciled abroad, is Zurich, subject to mandatory statutory provisions on jurisdiction.
